Application addressed to the Head of the Department of City Planning and Architecture, telephone number.  2. Passport data of the applicant, pages 1,2,3,11, ID code (for individuals).  Statement / certificate of state registration of a business entity (for legal entities).  3. Documents of the ownership or use of a plot of land with a land plan and a cadastral parcel number of land.  If there is no p. 3 - cadastral plan of the land with a catalog of coordinates of angles of external land borders, or a copy of the documents certifying the ownership or use of the premises and technical passport.  4. If there are buildings or structures on the land - a copy of the documents certifying the ownership or use of premises (building construction) and technical passport.  To get the information from urban cadaster:  1. Application addressed to the Head of the Department of City Planning and Architecture, telephone number.  2. Passport data of the applicant, pages 1,2,3,11, ID code (for individuals).  Statement / certificate of state registration of a business entity (for legal entities).  3. Scheme of location of land.  * Information from the urban cadastre is provided in the absence of legal documents to land and cannot be used to obtain basic data for the design or execution of any permits.
