Copy of certificate of ownership (barter, purchase and sale, granting, etc.) for housing that is planed to be bought on child's name. A copy of the technical passport of the apartment (house). Information on the indebtedness status of the housing that will be bought. A copy of the child's birth certificate. Act on living conditions of the apartment, which is planned to be bought on child's name. Copy of certificate of marriage (divorce, death of parents, certificate of Civil Registry Office on the basis of records of the father in the birth certificate of the child). Certificate of family members and of occupied living space from the child's place of registration. A copy of the technical passport of housing that parents are obliged to buy (house must be put into operation). Copy of certificate of ownership (barter, contract of purchase-sale, deed of gift) for housing that parents are obliged to purchase; extract from the state register of real estate. Copies of passports and identification numbers of parents and children. Protocol of children opinion aged 10-14 years (issued by the administrator of the Center of administrative services delivery when submitting complete package of documents).
